You will need to inform the RMT about this process and know their regular hourly fee will likely be charged. See the back of this form for further information and required documentation. Additional Requirements of Accepted Applicants:

1. Police Records Check for Service with the Vulnerable Sector (PRCSVS)

Successful completion of field placements or clinical placements in community agencies are a requirement for all students in this program. As required by community agencies, students are required to complete a **PRCSVS** screening prior to having direct contact with students and other vulnerable persons and is provided by a recognized Police Service. The resulting form must be made available to the field placement coordinators and agency officials when requested.

The time needed to obtain clear PRCSVS can vary. You are advised to start the process 4 - 6 months before the start of the program. Students failing to complete this by the program deadline cannot participate in the field placement component of the program. The PRCSVS screenings are valid for 12 months only and will require updating annually and must be valid through to May of the current school year. Students are responsible for the costs associated with this screenings.

Students who have a criminal record for which they have not been pardoned, may be unable to participate in field placements and therefore unable to meet the program requirements for graduation. Students are required to disclose outstanding criminal charges or other notations on their criminal records check. If this applies, students **must** contact your Program Chair prior to their field placement for the program.
