THE ROBERT C. GILLETT LEADERSHIP AWARD

A certificate and monetary prize are awarded to a graduating student in a degree, diploma or certificate program at the three campuses to recognize students who demonstrate exemplary volunteer leadership which contributes to the overall Algonquin College Student experience.

THE PRESIDENT ROSSER PRIZE

A certificate and monetary prize are awarded to a graduating student in a degree, diploma, or certificate program whose performance within the College community has been outstanding in terms of leadership and participation in student activities and who, as well, has maintained a good standard of scholastic achievement in his/her studies.

THE INTERNATIONAL HOUSE PRIZE

A certificate and monetary prize are awarded to the best all-round graduating student in a degree, diploma, or certificate program, attending Algonquin College on a student visa. Selection is based on academic achievement and active participation in extracurricular activities within the College community.

THE STEVE STAFFORD MEMORIAL CONTINUING EDUCATION AWARD

A plaque and monetary prize are awarded to a graduating student demonstrating unusual or extra effort while having completed a continuing education Diploma/Certificate or having completed the majority of a Post-Secondary Program through continuing education.
